## The United States of America,

To all to whom these presents shall come, Greeting:

WHEREAS, by the Act of Congress approved July 27, 1866 (14 Stat. 292), and Joint Resolution of June 28, 1870 (16 Stat. 382), "to aid in the Construction of a Railread and Telegraph Line from the States of Missouri and Arkansas to the Pacific Coast, " and to secure to the Government the use of the same for Postal, Military and other purposes authority is given to the Southern Pacific Railroad Company of California, a corporation existing under the laws of said State, to construct a Railroad and telegraph line under certain conditions and stipulations as expressed in said act from the City of San Francisco, to a point of connection with the Atlantic and Pacific Railroad near the boundary line of said State, and provision is made for granting to the said company, every alternate section of public land, not mineral, designated odd numbers, to the amount of ten alternate sections per mile, on each side of said railroad on the line thereof, and within the limits of 'twenty miles on each side of said road, not sold, reserved, granted or otherwise appropriated by the United States and free from preemption or other claims or rights, at the time the line of said road is definitely fixed; and

WHEREAS, it is further provided in said act "That the word 'mineral' when it occurs in this act, shall not be held to include iron or coal;" and

WHEREAS, it has been shown by evidence filed in the Department of the Interior that the entire line of the Southern Pacific (Main Line) Railroad and Telegraph from San Jose to the Needles, on the Colorado River, except that portion between Tres Pinos and Alcalde, which was declared forfeited by the Act of September 29, 1890, has been fully completed and equipped in the manner prescribed by said act of July 27, 1866, and accepted; and

WHEREAS, it is shown by certain papers filed in the Office of the Commissioner of the General Land Office by the duly authorised attorney of the Southern Pacific Railroad Company with his letter of April 30, 1902, that said Southern Pacific Railroad Company is the successor by consolidation with the Southern Pacific Railroad Company of California; and

WHEREAS, the following tracts have been listed under the acts aforesaid by the duly authorised land agent of the said Southern Pacific Railroad Company of California, or its successor, as shown by his original lists approved by the local land officers and now on file in the General Land Office; and

WHEREAS, the said tracts of land lie coterminous to the constructed line of said road, within twenty miles thereof, and are particularly described as follows, to-wit:

Mount Diablo Meridian, California.

Township thirty south of Range thirty-three east,

The Lot two of Section twenty-nine and the morth half of the northwest quarter of the northeast quarter, the southeast quarter of the northeast quarter, the east half of the southeast quarter of the northeast quarter, the north half of the southeast quarter of the northeast quarter, the southeast quarter of the southeast quarter, the west half of the northeast quarter of the southeast quarter, the southeast quarter of the northeast quarter, the southeast quarter of the northeast quarter of the southeast quarter, the southeast quarter of the northwest quarter of the southeast quarter, the southeast quarter of the northwest quarter of the southeast quarter, the southeast quarter of the Lot seven, and the west half of the Lot seven of Section thirty-one.

Township thirty-one south of Range thirty-seven east,

The northeast quarter of the northeast quarter of Section seven.

San Bernardino Meridian, California.

Township eleven north of Range eight east,
The Lots three and four of Section twenty-five.

Township eleven north of Range nine east, The Sections thirty-one and thirty-five.

Township eleven north of Range ten east,

The Lots six and seven, the east half of the southwest quarter, and the southeast quarter of Section thirty-one, containing in the aggregate, one thousand nine hundred twenty-three acres and seventeen hundredths of an acre:

NOW KNOW YE, That the UNITED STATES OF AMERICA, in consideration of the premises, and pursuant to the said Acts of Congress, HAS GIVEN AND GRANTED, and by these presents DOES GIVE AND GRANT, unto the said Southern Pacific Railroad Company, successor in interest to the Southern Pacific Railroad Company of California, and to its successors and assigns, the Tracts of Land listed as aforesaid and described in the foregoing; TO HAVE AND TO HOLD the same, together with all the rights, privileges, immunities, and appurtenances, of whatsoever nature thereunto belonging, unto the said Southern Pacific Railroad Company, and to its successors and assigns, forever.
